

HOME RENOVATION SAVING HRS program







- · At least 2 Renovations must be completed.
- The home must be connected to Ontario Electricity.
- Both main and secondary residences are eligible, but the application must be made by the homeowner.
- The final audit must be carried out within 180 days of the initial audit.
- Eligible homes include only detached, semidetached, row, and mobile homes on a permanent foundation.
- The maximum total rebate is \$5,000(Enbridge gas heated) or \$10,000(Electricity heated), which includes a \$600 reimbursement for the Audit Fee.
 This rebate applies for the lifetime of the program per address.

Exposed Floor Insulation	Add at least R20	
	Minimum area required is 11 square meters or 120 square feet, applicable to overhangs or floors above garages	\$300





Foundations	Basement Header _ Add at least R20 to 80%	\$ 300
When both a basement and crawlspace are present, grants are adjusted proportionally up to a maximum of \$1,500, determined by the total wall area. Any combination of foundation wall and header upgrade counts as one measure. Semi-detached and row homes receive prorated benefits	Basement Wall -Add at least R10 to R22 to 100%	\$ 900
	Basement Wall - Add at least R23 to 100%	\$ 1, 500
	Crawlspace Header - Add at least R20 to 80%	\$ 300
	Crawlspace Wall - Add at least R10 to R22 to 100%	\$ 600
	Crawlspace Wall - Add at least R23 or greater to 100%	\$ 1,200
Foundation Slab	For basement/crawlspace slabs, add a minimum of R3.5 insulation to 50% of the entire slab area	\$ 500
Crawlspace Ceiling	The incentives depend on insulating either the crawlspace wall or ceiling. Semi-detached and row homes receive prorated benefits, Crawlspace Ceiling - Add at least R24 and above to 100%	\$ 1,200
Window , Sliding Doors , Hinged Door ,Skylight	Replace Window - Minimum of 3 windows replaced	• \$ 100
	Replace Sliding Door	• \$ 100
Note: Energy Star stickers must be retained for the Final Audit.	Replace hinged doors	• \$ 100

Air Sealing Should only be considered for 4th or 5th measure for older homes	Achieve the target outlined in your report	• \$ 200
	Achieve 10% above the target specified in your Receipts for air sealing are required. Hiring a professional is advisable.	• \$ 250
Water Heater Heat Pump	Restore your domestic water heater to an ENERGY STAR certified domestic hot water heat pump (DHW- HP) The water heat pump must be listed on the NRCan Eligible List . Also Eligible for Rental Units	\$ 500
